A notarial deed on two pages of the contract of sale of certain lands, granted by Paula Olivares and her daughter in favour of Pascual Delgado, given in Churín on 24 August 1883 before the justice of the peace of that town; it has the original foliations 54 and 55; on page 54 it has 13 postal stamps, on page 55 it has 19 stamps. It is an original document with signatures of grantors and notary, the handwriting is italic. It corresponds to document 100, file 4, Civil Causes series from the Notary Aristónico Demetrio Ramírez Suzaníbar of Cajatambo collection.

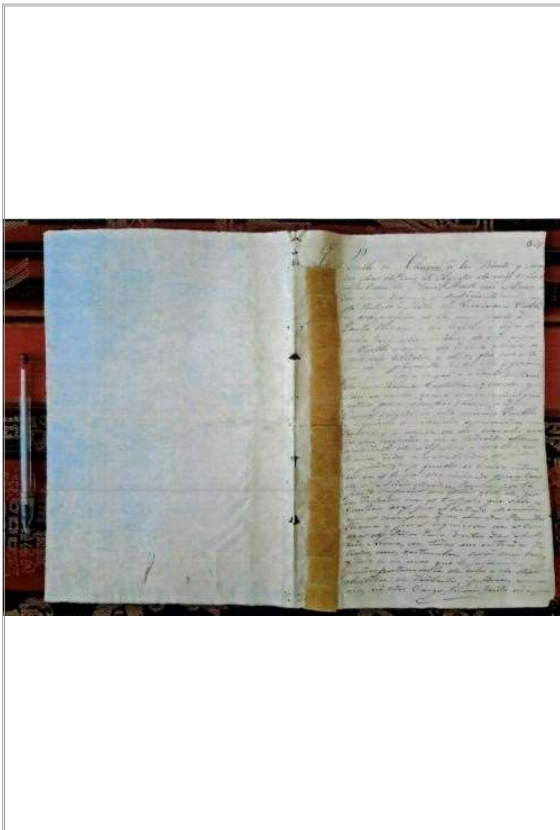

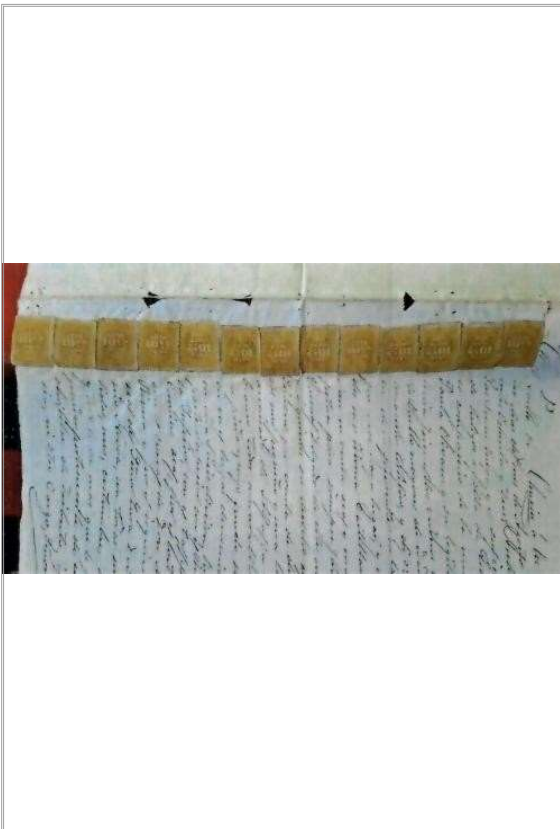

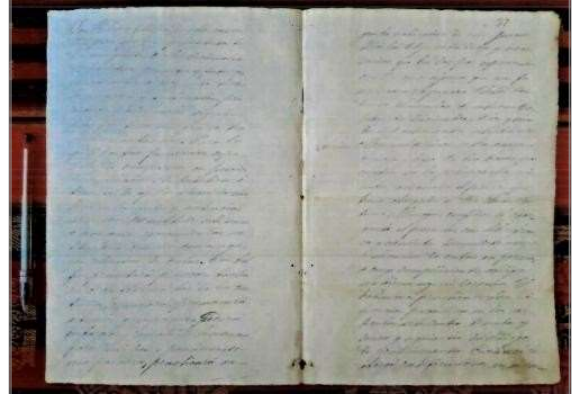
